2. Purpose

- 2.1 The purpose of this Bulletin is to inform of the List of Approved Providers of Insurance for Barbadian vessels and for the following purpose:
 - .1 All ships - P&I Certificate of Entry for general liability;
 - .2 Any ship greater than 1000 Gross Tonnage - Article 7 of 2001 the Bunkers Convention;
 - .3 Any ship carrying more than 2000 tons of oil in bulk as cargo- Article 7 of the 1992 Civil Liability Convention;
 - .4 All seafarers on any ship - Repatriation (Reg 2.5) and Shipowner's Liability (regulation 4.2) of the MLC 2006;
 - .5 Any ship in international voyage- Article 4bis of the PAL 2002;
 - .6 Any ship of 300 Gross Tonnage and above - Article 12 of the Wreck 2007.
- 2.2 This bulletin supersedes Bulletin number 338.

3. Removal of Wrecks Certificate (2007 Nairobi WRC)

- 3.1 Barbados is not signatory of the Nairobi International Convention on the 2007 Nairobi WRC.
- 3.2 The Barbados Maritime Ship Registry (BMSR) cannot issue a certificate attesting that insurance or other financial security is in force in accordance with the provision of the Convention.
- 3.3 However, the BMSR still requires Barbadian vessels to be insured for the purpose of the convention and to receive a valid certificate of insurance.
- 3.4 Managers who still wish to have a statutory Wreck Certificate, can apply for one to an appropriate authority of any other State Party of the Convention.
